Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission these brief Reply Comments in response to the Department of Commerce – Division of Energy Resources' Comments received on March 31, 2020. We appreciate the Department's thorough review of our Report and recommendation of approval. As the Department noted in their Comments, we plan to meet to discuss possible changes to our decoupling mechanism if it is to continue.

In Comments, the Department requested the Company provide a comparison of our 2019 CIP achievements to our CIP achievements during the three-year decoupling period, 2013-2015, when the 2019 CIP achievements are available. As noted in the Department's Comments, the Company's 2019 CIP Status Report is due May 1, 2020. However, our electric and natural gas CIP Adjustment Factor filings were submitted on April 1, 2020. In these filings we reported our total CIP achievements for 2019. Using that data, we provide the information requested by the Department in Table 1 below.

An analysis of the Company's full CIP savings results will be presented in our 2019 CIP Status Report, which will be filed on or before May 1, 2020 (Docket No. E,G002 CIP-16-115.08).

The Department noted that future analysis of different regulatory policies and how they interact will be needed in order to inform the discussion of how Minnesota's greenhouse gas goals can be reached at a least cost or reasonable cost basis. The Company is supportive of continued engagement on these topics. The Company notes there are other dockets that may include discussions relevant to this topic, such as various Electric Vehicle dockets,² the Performance Metrics docket,³ the CIP triennial filing,⁴ the Resource Plan docket,⁵ and the CO2 regulatory costs docket.⁶

Lastly, upon our review of the Department's Comments we discovered some RDM factors with differing sign conventions for credits and surcharges. Table 2 below provides the RDM factors for the four-year decoupling pilot.
