In the Matter of the Petition by Great Plains Natural Gas Co., a Division of Montana-Dakota Utilities Co., for Authority to Increase Natural Gas Rates in Minnesota Notice of Schedule for Filing Exceptions to the ALJ's Report and Request for Great Plains Natural Gas Co. to File Schedules Reflecting the ALJ's Recommendation
