The Office of the Attorney General-Residential Utilities Division ("OAG") respectfully submits this letter in response to the Joint Petitioners' Request for Deferred Accounting of COVID-19 Related Costs ("Petition") filed by the rate-regulated Minnesota electric and natural gas utilities on April 20, 2020, and the Notice of Commission Meeting ("Notice") issued by the Public Utilities Commission ("Commission") on April 27, 2020. The Notice provides for a hearing on this matter on May 7, 2020, thirteen days prior to the May 20, 2020 comment deadline, to discuss how "the Commission wish[es] to proceed with respect to [the Petition]." As of the date of this letter, no parties have submitted comments addressing the merits of the Petition.

To the extent that it informs the Commission's procedural decisions on this matter, the OAG writes to inform the Commission that, consistent with its role as an advocate for residential and small business ratepayers,¹ it is in the process of analyzing the Petition and intends to submit
