In the Matter of the Petition of the Minnesota Rate Regulated Electric and Gas Utilities for Authorization to Track Expenses Resulting From the Effects of COVID-19 and Record and Defer Such Expenses into a Regulatory Asset E,G-999/M-20-427

Dear Mr. Seuffert:

Dakota Electric Association® (Dakota Electric® or Cooperative) files this quarterly compliance filing in response to the Minnesota Public Utilities Commission's (Commission or MPUC) May 22, 2020 Order and the Commission's June 25, 2020 Notice of Clarification Of Quarterly Reporting Requirement in the above-referenced docket. The May 22 Order directed utilities to submit quarterly compliance filings as follows:

The Joint Petitioners' April 20, 2020 Petition is granted with the caveat that the grant is for accounting purposes only. Further, the utilities must track costs and revenues or grants incurred or received as a result of the COVID-19 pandemic. They must make an initial filing of their accounting methodology and known and estimated costs and revenues within the specific categories in 21 days, and quarterly thereafter. The utilities still bear the burden to establish significance, reasonableness, prudence, and the incremental nature of the costs.

The Commission's June 25, 2020 Notice of Clarification of Reporting Requirements stated:

The Executive Secretary makes the following clarification to the Commission's Order:

1. For the duration of this proceeding, quarterly compliance filings for the quarters ending in March, June, September and December will be due 30 days after the end of each respective quarter.

2. The first quarterly report will be due on or before July 30, 2020.

3. Compliance filings will include estimates of any COVID-related costs or offsets that are known at that time.

4. All quarterly reports must include an accounts receivable aging, by class, using a format similar to the one below:

Dakota Electric Quarterly Compliance

Dakota Electric's quarterly compliance provides an overview of the Cooperative's COVID-19 financial impacts through June.

Dakota Electric's identification of COVID-19 financial impacts is accomplished through two processes. First, Dakota Electric is tracking COVID-19 expenses through a COVID project code and reviewing other expenses that are not expected to be incurred due to the pandemic. These expenses and off-setting credits are identified as discrete dollar amounts. Second, some COVID-19 financial impacts are determined as a calculation, with the net impact being stated in reference to a base amount being recovered in electric rates. That is, certain revenues and expenses have been included in the test year for a past general rate case. However, the COVID-19 pandemic, and responses requested of utilities, has affected the level of those revenue and expenses in relation to the amount being recovered in present rates. The attached spreadsheet identifies the actual and estimated net expenses through June 2020. Dakota Electric's electric rate accounts receivable aging by class through 6/30/2020 is as follows:
