Dear Mr. Seuffert and Deputy Commissioner Ranade:

On behalf of the Xcel Large Industrials ("XLI") and with the support of the Office of the Attorney General – Residential Utilities Division ("OAG"), and Citizens Utility Board ("CUB"), we respectfully request that the deadlines for initial comments be due on October 16, 2020, for the applicable above referenced dockets. XLI sets forth the rationale for this request below.

On July 23, 2020, the Minnesota Public Utilities Commission (“Commission”) issued its *Order Accepting Integrated Distribution Plan, Modifying Reporting Requirements, and Certifying Certain Grid Modernization Projects* in MPUC Docket No. E002/M-19-666. (“IDP Acceptance Order”). Relevant here, the IDP Acceptance Order requests that the Minnesota Department of Commerce – Division of Energy Resources (“Department”), file a report by November 1, 2020, that includes “recommendations on specific metrics, detailed methods for evaluating performance, and consumer protections or other conditions, including cost caps, that should be applied to the certified projects.” *IDP Acceptance Order*, Ordering Para. 9, pg. 16. The IDP Acceptance Order also required Northern States Power Company d/b/a Xcel Energy (“Xcel”) to file procedural paths forward, with one option being a contested case, sixty days prior to any petition for rider recovery for advanced grid intelligence and security (“AGIS”) costs. *IDP Acceptance Order*, Ordering Para. 134, pg. 17.

On August 20, 2020, and in pursuit of compliance with the IDP Acceptance Order, the Department issued a Notice of Solicitation of Stakeholder Input and Comments in MPUC Docket No. E999/DI-20-627 (“IDP Stakeholder Notice”). Relevant here, the IDP Stakeholder Notice set a comment due date of September 18, 2020, presumably to provide the Department with sufficient time to prepare the November 1 report requested by the Commission in the IDP Acceptance Order.

On August 28, 2020, Xcel submitted a petition for Commission approval of AGIS costs, namely those related to advanced metering infrastructure (“AMI”) and field area network (“FAN”), initiating MPUC Docket No. E002/M-20-680 (“IDP TCR Petition”). The IDP TCR Petition was also filed in MPUC Docket No. E002/M-19-666. To date, no comment deadline has been established by the Commission. If a miscellaneous comment process is utilized, stakeholder comments in response to the IDP TCR Petition will presumably be due September 28, 2020. Minn. R. 7829.1400.

On August 12, 2020, the Commission issued a Notice of Comment Period in MPUC Docket No. E,G002/M-20-492, requesting utility filings proposing investments to assist Minnesota’s economic recovery from the COVID-19 pandemic by September 15, 2020. On September 15, 2020, Xcel submitted a petition seeking approval of its \$3 billion investment plan that may assist in Minnesota’s economic recovery from the COVID-19 pandemic (“COVID-19 Petition”). This filing also initiated MPUC Docket No. E,G002/M-20-716. Xcel proposes approximately \$462 million of distribution system investments during the 2021-2025 timeframe in the COVID-19 Petition. The Commission has established deadlines of October 16, 2020, for initial comments and October 30, 2020, for reply comments in Docket 20-492.

Stakeholders need time to digest and understand the potential cost impacts associated with the IDP TCR Petition and COVID-19 Petition, and whether the proposed distribution system investments are related and/or overlap between those two filings. Stakeholders also need time to process whether, and the extent to which, the performance metrics subject to comment in the IDP Stakeholder Notice, will be influenced by the IDP TCR Petition and COVID-19 Petition, both of which were filed after the IDP Stakeholder Notice.

In order to provide stakeholders with this time, while also aligning deadlines and recognizing the interest of time and the limited resources of parties and Commission staff, XLI respectfully requests the Commission set forth the following deadlines:

- Modify the November 1, 2020, requested date for the Department's report in compliance with the IDP Acceptance Order to December 1, 2020, which modification would allow the Department to extend its due date in the IDP Stakeholder Notice by approximately 30 days to October 16, 2020;¹
- Set the initial comment deadline in response to the IDP TCR Petition on October 16, 2020; and
- Set the initial comment deadline in response to the COVID-19 Petition on October 16, 2020.

Accordingly, XLI respectfully requests the Department extend the due date for comments in its IDP Stakeholder Notice to October 16, 2020.

XLI has coordinated with OAG and CUB on this request and understands these two stakeholders support the relief and deadlines proposed by XLI. We have also consulted with the Department and understand the Department has no objection to this request.
