LIUNA MINNESOTA & NORTH DAKOTA COMMENT

The Laborers District Council of Minnesota and North Dakota "LIUNA Minnesota & North Dakota" appreciates the opportunity to offer comments in support of CenterPoint Energy's proposed Renewable Natural Gas ("RNG") Interconnection Tariff.

LIUNA Minnesota & North Dakota represents 12,000 unionized construction laborers statewide, including hundreds of members who earn a living building and maintaining natural gas pipelines and distribution lines. Our members are proud of the role they play in ensuring that millions of Minnesotan can count on safe, reliable, and affordable gas service to heat their homes, cook their food, and fuel their businesses.

Climate change is forcing many industries to develop innovative strategies for reducing greenhouse gas emissions, and gas utilities are no exception. In Minnesota, CenterPoint is leading the way, and the company's proposed RNG tariff is an important building block in an effort that could help meet climate goals while also preserving jobs and ratepayer-funded investments in natural gas infrastructure.

CenterPoint's proposal would allow Minnesota-based RNG producers to access existing gas infrastructure to move low-carbon and net-zero natural gas to customers nationwide. This would be accomplished at no added cost to ratepayers, since the proposed tariff would allocate those costs to producers, and if successful the initiative could ultimately help lower costs for ratepayers through new revenue from producers.

The tariff would create a figurative and literal pipeline for farmers, municipal waste operations and clean energy companies to move captured methane or clean-burning hydrogen to potential customers. Such a pipeline would create opportunities for jobs and economic development, especially in parts of Greater Minnesota where they are needed most. The American Biogas Council estimates that fully developing the state's renewable natural gas potential could create more than 18,000 construction jobs, and establishing an RNG interconnection tariff is a first essential step.

For LIUNA members, however, it's not just a question of new jobs but also of preserving existing jobs. In 2019, construction and maintenance of natural gas distribution lines provided family-supporting wages, health and retirement benefits to more than 800 LIUNA members who logged over 900,000 hours of work, of which CenterPoint projects accounted for roughly half. Hundreds more worked on natural gas pipeline projects that serve the distribution system.

Companies like CenterPoint, Xcel, and MERC have been among our most reliable partners and sources of high-quality jobs. We don't know what the future holds for natural gas utilities, but our members who work in the industry want and deserve the opportunity to show that they can contribute to the fight against climate change and build a system capable of helping to meet climate goals.

They won't get that chance, however, unless the Commission approves mechanisms for gas utilities to transport and sell low and zero-carbon natural gas. CenterPoint's proposal is the first step and we urge the Commission to take it.
