Chambers Family Farms, LLC has signed a land lease/solar easement with Geronimo Energy for the potential to build the Elk Creek Solar project on its family's property. Chambers Family Farms, LLC fully supports the development of this solar project and is hoping that it will be permitted by the MN Public Utilities Commission (MN PUC) and built as planned. As a multigenerational landowner, it is exciting prospect for the Chambers family to be able to expand renewable energy from their family's property. The Chambers family believe the State of Minnesota and Xcel Energy have been very progressive and proactive in supporting renewable energy efforts and fully support the potential to build this solar project and offset energy produced from fossil fuels/coal/nuclear energy for the next 50+ years! Members of the family have been involved with solar energy in their careers and are passionate about the solar industry and renewable energy. Yes, there will be some farmland that is displaced to solar panels.
