Specific members of the Large Power Intervenors ("LPI")¹ submit the attached letters of support for Minnesota Power's petition to extend the Energy-Intensive, Trade-Exposed ("EITE") discount until final rates are implemented in Minnesota Power's next rate case filing.

Previously, the Minnesota Public Utilities Commission ("Commission") ordered that the expiration of the EITE discount be restored to the historic expiration date of February 1, 2021.² The Commission further ordered Minnesota Power to make an extension proposal by August 31, 2020.³

I am writing on behalf of Cleveland-Cliffs, Inc. and its United Taconite facility in support of Minnesota Power's request for an extension of the Energy-Intensive Trade-Exposed (EITE) discount.

United Taconite operates an iron ore mine in Eveleth, MN and a taconite processing plant in Forbes, MN. The facility produces approximately 5.4 million tons of iron ore pellets annually, which are shipped from the Duluth harbor to steelmaking customers on the Great Lakes. United Taconite has been in operation since 1965, employs 515 people and has an annual economic impact of \$328 million.

The EITE discount is an important tool for United Taconite to maintain affordable electric power rates, which is one of the largest cost inputs in the pellet-making process. Energy inputs account for approximately 20 - 25% of the cost of making pellets. Maintaining affordable electric rates is important because our customers in the steel industry compete globally with steelmakers in foreign countries that are not always required to meet the high regulatory standards we have in the United States. We are proud to make environmentally-friendly pellets and clean steel, but need to be able to do so at costs that keep us competitive.

On top of these global industry dynamics, the recent COVID-19 pandemic had an immediate impact on United Taconite's steel customers and end-use manufacturers in the automotive and construction sectors. In May, the steel industry capacity utilization rate for the United States was 53.7%, which is a reduction of nearly 30% over the same period in 2019. While the steel industry is in a very slow recovery, steel capacity utilization had reached only 63% during the week ended August 22, 2020. This contraction in the steel industry resulted in the idling or partial idling of four iron ore mines in Minnesota. While United Taconite was fortunate to continue production during these challenging market conditions, the facility instituted cost-cutting measures to balance the economic headwinds caused by the pandemic

These factors are evidence that the COVID-19 pandemic has heightened the economic challenges the iron mining and steel industries faced when EITE was first implemented. A decision to eliminate the discount would result in a ~4% rate increase for EITE customers as we work to overcome the impact of the pandemic and provide iron ore pellets that will be imperative to the nation's economic recovery and the reshoring of critical manufacturing sectors.

Cleveland-Cliffs respectfully encourages the Minnesota Public Utilities Commission to support Minnesota Power's EITE extension request. Stable and competitively-priced power rates continue to be crucial components to maintain competitiveness for the iron mining and steel industries now and in the future.

- Packaging Corporation of America's Minnesota paper mill produces ~450,000 tons/year of BOISE® brand office papers in International Falls providing 612 direct jobs in the region along with 350 contract jobs.

- Sappi Cloquet LLC located in Cloquet, MN employs approximately 730 employees with an annual production capacity of 340,000 metric tons of coated woodfree paper and 340,000 metric tons of dissolving pulp. The Cloquet Mill is home to the production of Sappi's premium publication grades, GalerieArt, Opus and McCoy, as well as one of Sappi North America's newest products, dissolving pulp (DP), which entered the market in 2013.
- The fundamental economic challenges Sappi faced when the Minnesota Legislature passed the EITE statue in 2015 have been further exacerbated by the COVID-19 pandemic.
 - o Sappi Cloquet has faced loss of sales, a permanent decline in demand, and significant production curtailments as a result of COVID-19.
- These current economic conditions and unprecedented times are not the time to be eliminating the discount come February 2021. Doing so would result in electric rates increasing for EITE customers by approximately 4% immediately, compounding the effects of COVID-19.
- Extending the discount until Minnesota Power's next rate case would be the most appropriate time and venue for the Commission to more fully review rates and rate design.

We strongly encourage the Minnesota Public Utilities Commission to support Minnesota Power's EITE extension request and we look forward to working with Minnesota Power on rate design alternatives and the other components of the competitiveness filing.

On behalf of United States Steel Corporation, I am writing to express support for Minnesota Power's request to extend the EITE discount. United States Steel Corporation's Minnesota Ore Operations (or MOO) consist of two taconite mining operations known as Minntac (in Mt. Iron, MN) and Keetac (in Keewatin, MN). The annual production capability for MOO is approximately 22 million tons of taconite pellets per year.

MOO is a major employer in northeast Minnesota, employing roughly 1,800 people at normal operating levels. The fundamental economic challenges MOO faced when EITE was first implemented *not only continue but have been further exacerbated by COVID-19* today. The primary consumer of taconite pellets produced at Minntac and Keetac are U. S. Steel's own blast furnaces. However, in response to the market conditions created by COVID-19, U.S. Steel has temporarily idled four of its North American blast furnaces, impacting production at Minntac and Keetac. The Keetac location remains indefinitely idled.

We understand the EITE discount is currently scheduled to sunset in February 2021. The current economic conditions and unprecedented times, which have directly impacted MOO, are not the time to be eliminating the EITE discount. Doing so would result in rates increasing for EITE customers by ~4% overnight, which would be contrary to state energy policy set forth in the EITE statute.

Energy costs are a significant component of MOO's production costs and ensuring competitively priced electricity is critical to MOO's operations going forward. We strongly encourage the Minnesota Public Utilities Commission to support Minnesota Power's EITE extension request. In the meantime, we look forward to working with Minnesota Power on rate design alternatives and the other components of Minnesota Power's competitiveness filing.
