RE: Petition of CenterPoint Energy for Approval of a Rule Variance to Minnesota Rules Regarding Supplier (Pipeline) Refunds – Supplemental Reply Comments to the Department's Supplemental Comments

Dear Mr. Seuffert:

On November 23, 2020, CenterPoint Energy (the "Company") submitted a request for approval of a variance to Minnesota Public Utilities Commission ("Commission") Rules Regarding Supplier Refunds- Minnesota Rule 7825.2700, Subp. 8. (Refunds) in accordance with the requirements of 7829.3200 (Other Variances).

On January 4, 2021, the Department of Commerce, Division of Energy Resources (the "Department") filed Supplemental Comments in response to the Company's December 28, 2020 Reply Comments. The updated recommendation included that the Commission:

- approve the Company's proposed refund amount and interest calculations.
- approve CenterPoint's calculation of the refund amount per unit and allocation to customer classes
- **approve** the Company's proposal to provide a bill credit to all customers who have active accounts as of the date of the refund.
- **approve** the Company's requested variance to Minn. R. 7825.2700, subp. 8 relating to the use of 4 months of customer data to determine the refund per unit amount.
- **approve** the Company's requested variance to Minn. R. 7825.2700, subp. 8 that would allow CenterPoint more than 90 days to provide the refund discussed in CenterPoint's Reply Comments.
- **require** CenterPoint to report on the status and provide a reconciliation of the refund's disbursement.

The Company supports the recommendations outlined in the Department's analysis and confirms it will provide a reconciliation of the refunds in a subsequent compliance filing after the refunds are processed.
