Dear Mr. Seuffert:

Big Bend Wind, LLC ("Big Bend") and Red Rock Solar, LLC ("Red Rock") (collectively, "the Applicants"), are indirect wholly-owned subsidiaries of Apex Clean Energy Holdings, LLC and are proposing to construct up to 335 megawatts ("MW") of new renewable energy generation. As proposed, the renewable generation could consist of up to 308 MWs of wind (the "Wind Farm"), or a combination of wind and up to 60 MW of solar (the "Solar Project"). In addition, Big Bend is proposing to construct a 161 kilovolt ("kV") transmission line and associated facilities to support the Wind Farm and Solar Project.

The Applicant has also designated as NONPUBLIC Appendix F of the Site Permit Application because it contains sensitive cultural and environmental information. Because Appendix F is nonpublic in its entirety, the Applicant is filing only a cover page as the public version of Appendix F.
