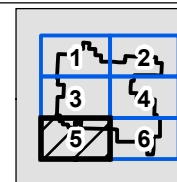
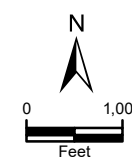


MAP 12 - UNIQUE NATURAL FEATURES - PAGE 5 OF 6

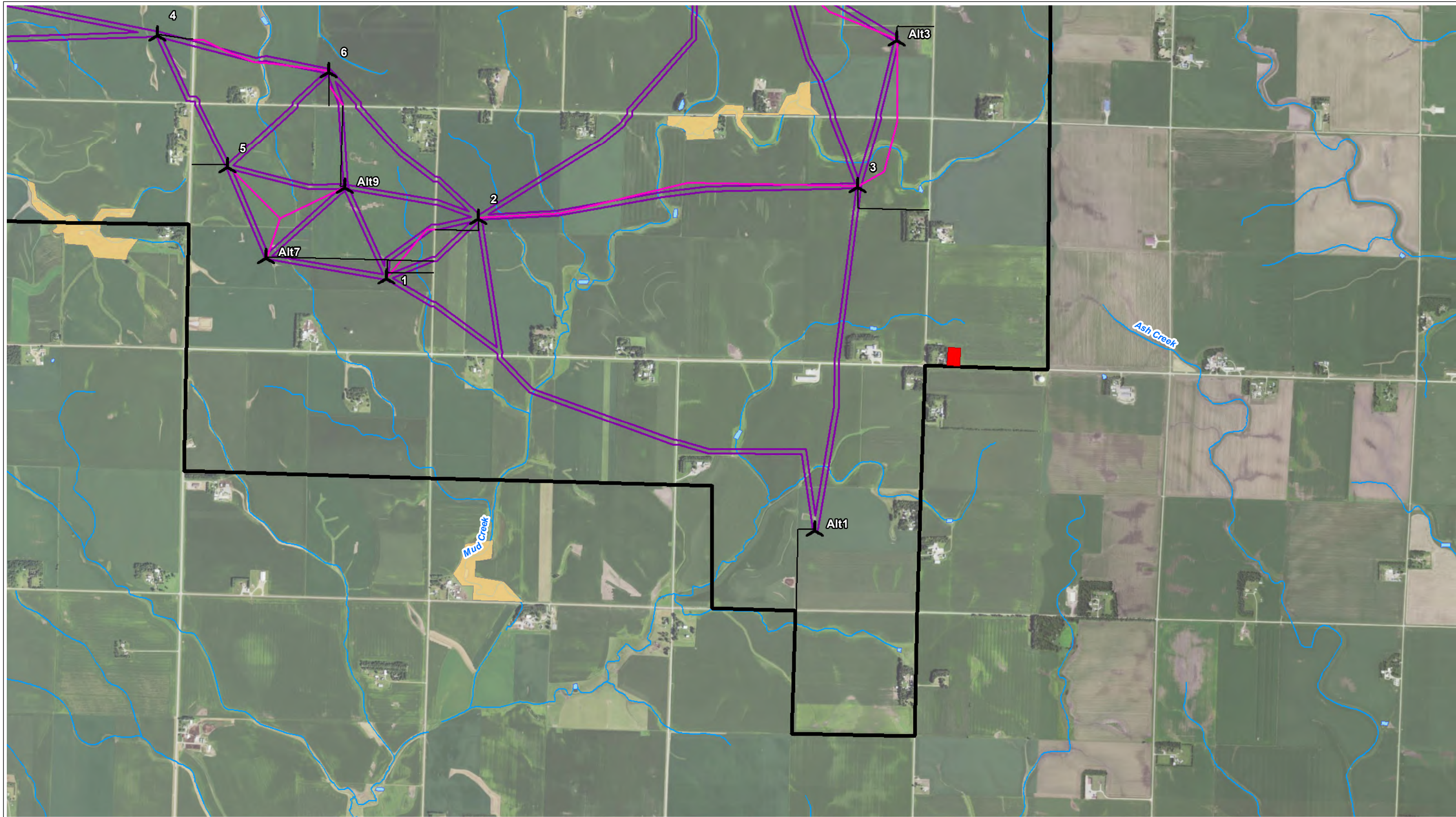

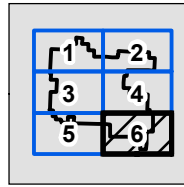
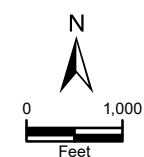


MAP 12 - UNIQUE NATURAL FEATURES - PAGE 6 OF 6

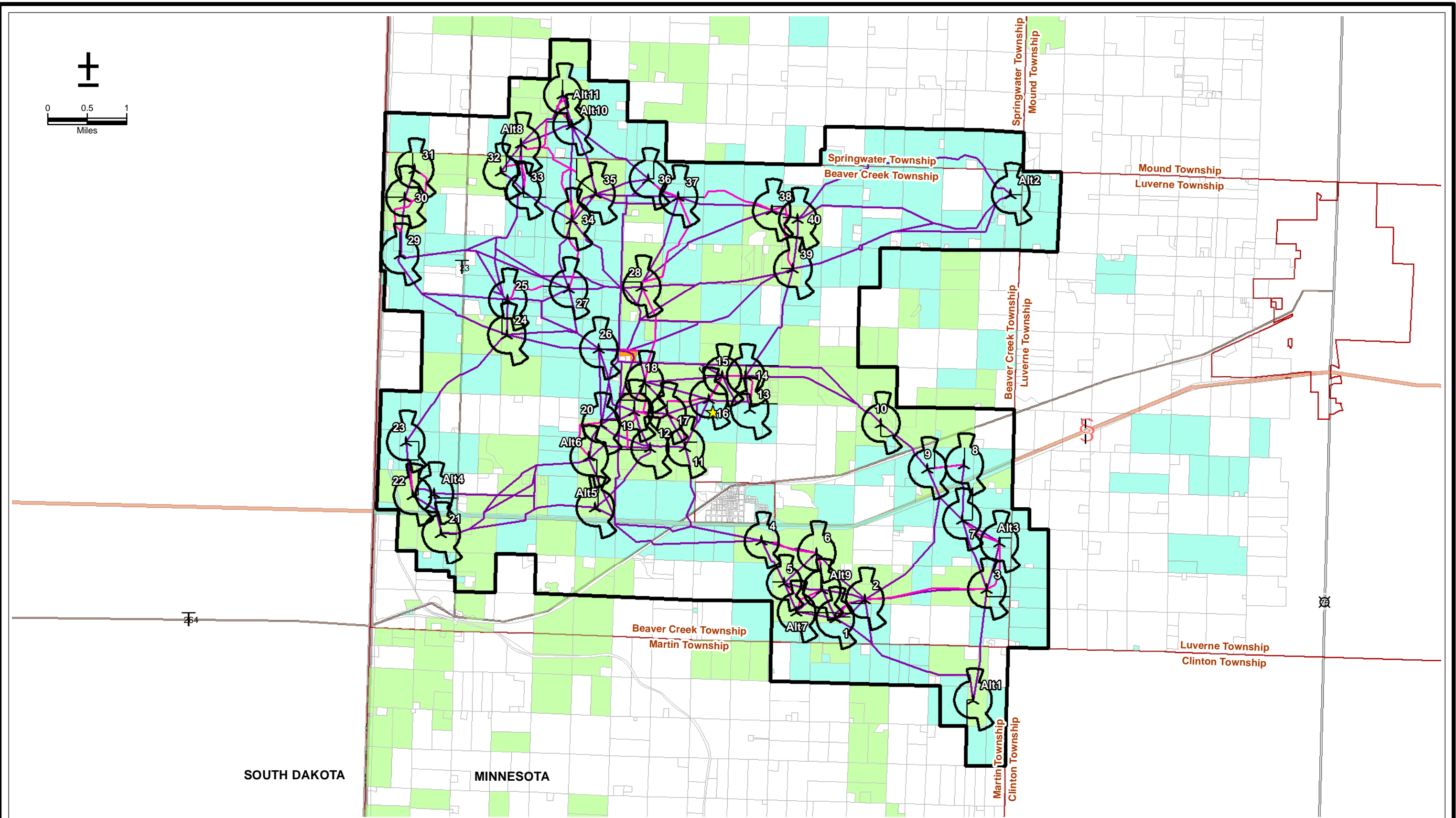


MAP 14 - SITE GEOLOGY AND DEPTH TO BEDROCK

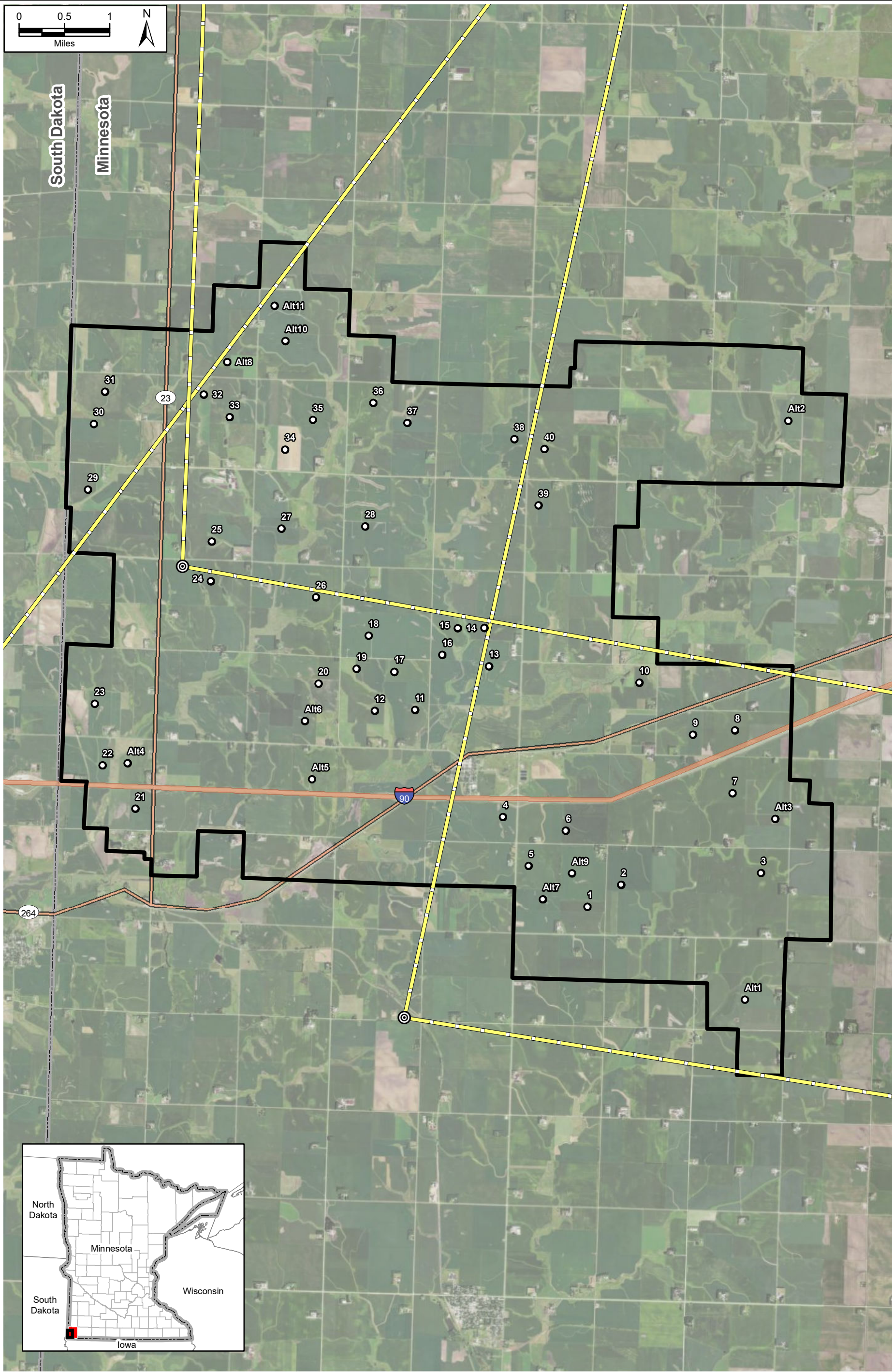
