The Department offers the following language for Revised Decision Option subpart 2.a.

2.a. Require that the qualifying amount of the *short-term incentive compensation paid* that is

compared to the base rate recovery amount, be limited to the lower of (1) the 15 percent incentive cap at the 100 percent target achievement, or (2) the amount paid. [Department] [Note: If decision option 2.a. is selected and 2.b. is not, no refund would be required.]
