**Issue:** Should the Commission grant an amended certificate of authority to Big River Telephone Company (Big River), LLC.?

Please provide any call logs that verify the allegations made by Garden Valley. Any other information that Garden Valley deems relevant to the allegations made by Garden Valley.
- Other parties should respond to the information filed by Garden Valley in reply comments.
- Are there other issues or concerns related to this matter?

**Background** On January 26, 2021, Big River Telephone Company, LLC filed an application to amend its existing certificate of authority to allow the Company to provide local exchange services in the municipality of Red Lake Falls. Big River's application falls under Minn. Rules pt. 7812.0300, subp. 5 and Minn. Stat. §237.16, subd. 4.

On February 4, 2021, the Minnesota Department of Commerce filed comments recommending that the Commission grant approval of the petition, with conditions.

On February 10, 2021, Garden Valley filed a letter with the Commission expressing concerns regarding customer service issues that have previously arisen in a separate context involving Big

River. The customer service issues relate to failed completion of calls originating with current Big River customers who attempt to make calls to Garden Valley Thief River Falls CLEC customers who were formerly Big River customers.
