Case Background: On November 4, 2020, Minnesota Power requested authority to track and defer Net Lost Revenues incurred as a result of the idling of the Keewatin Taconite Mine (Keetac) and the Verso Duluth Paper Mill (Verso). The Commission has received comments from the Large Power Intervenors (LPI), Citizens Utility Board (CUB), the Office of the Attorney General (OAG), and the Minnesota Department of Commerce (Department).
