Sage Telecom Communications, LLC dba TruConnect (“TruConnect”), by counsel, respectfully submits to the Minnesota Public Utilities Commission (“Commission”) these Comments to the Notice of Comment Period Issued March 3, 2021 requesting comments to address whether or not the Commission should amend Ordering Paragraph 1 of its November 20, 2020 Order to allow Mobile Wireless Lifeline-Only ETCs subject to the Order to distribute the required notice within a month of new customer enrolling, rather than within seven (7) days.

TruConnect attended the February 2, 2021 meeting hosted by Commission staff and appreciated the opportunity for wireless lifeline ETCs to discuss the content and distribution requirements of the customer notice.
