Dooley's Natural Gas II LLC's Petition for Approval of a Small Gas Utility Franchise (Docket No. G6915/M-16-756).

Lake Region Energy Services Petition for Approval of a Small Gas Utility Franchise (Docket No. G6977/M-17-186).

The Department recommends that the Commission include an additional docket, Docket No. G6977/M-17-829 on the list for this proceeding in future years. This docket was not included in the Commission's Request for Comments but it appears it should be included. #### I. PROCEDURAL HISTORY

On May 20, 2021 the Minnesota Public Utilities Commission (Commission) issued a notice of comment period (Notice) relevant to the first five of these proceedings. The Notice identified one issue: "Should the Commission accept the compliance filings submitted by Community Co-Ops of Lake Park, United Natural Gas, LLC, Lake Region Energy Services Inc., Dooley's Natural Gas LLC and Dooley's Natural Gas II, LLC?"

The Notice also listed two topics for comments:

- Have the small gas utilities complied with the Commission's November 9, 2018 Order?
- Are there any other issues or concerns related to this matter?

In its November 9, 2018 ORDER DETERMINING COMPLIANCE WITH COMMISSION ORDERS AND ESTABLISHING FILING REQUIREMENTS (2018 Order), the Commission standardized the annual reporting requirements for the four small gas utilities covered by this Order and required them to file a report or letter annually by May 1 that provided updates to the data filed for 2019. That information included:<sup>1</sup>

- Updated customer counts, plus a statement that the utility does not discriminate between in-muni/out-muni customers, and if it does, why;
- B. Any municipality-approved rate changes that occurred in the prior year and when these changes went into effect. All small gas utilities must comply with Minn. Stat. § 216B.16, subp. 12 (b), which states "The public utility shall file with the commission and the department all initial and subsequent changes in rates, tariffs, and contracts for

service outside the municipality at least 30 days in advance of implementation.

- C. All changes to its tariff book in redlined and final revised tariff form;
- D. A copy of its cold weather disconnection notice sent to the customers, including how the notice was communicated and date communicated (Minn. Stat. § 216B.096, Minnesota's Cold Weather Rule);
- E. A copy of any utility disconnection reports served to any of the municipalities as required by Minn. Stat. § 216B.0976 – Minnesota's Notice to Cities of Utility Disconnection;
- F. A copy of its notice sent to customers who are in arrears, pursuant to the utility's obligation under Minn. Stat. § 216B.098 – Minnesota's Residential Customer Protections, along with any policy not clearly identified in the tariffs regarding budget billing plans, payment arrangements, and under-charge repayment.

The 2018 Order also allowed the exempt small gas utilities to file a letter stating that there were no changes to the data filed in the 2019 report if that were the case.

Each of the four affected companies filed their annual compliance reports on or before the Commission's May 1, 2021 deadline.<sup>2</sup>

#### II. DEPARTMENT ANALYSIS

The Department reviewed the Companies' 2021 compliance filings or letters to determine if they were consistent with the requirements contained in the Commission's 2018 Order. The Department organized these comments by docket number using a standardized checklist.

- A. COMPLIANCE FILINGS
  - 1. Dooley's Natural Gas LLC (Docket No. G6915/M-13-672)

Table 1 summarizes Dooley's Natural Gas LLC 2021 compliance filing and ensuing communications.
