FIRST PREHEARING ORDER

On March 12, 2021, Administrative Law Judge Jim Mortenson convened a prehearing conference in this matter. The prehearing was held via telephone conference call.

Brian Meloy, Stinson LLP, appeared on behalf of Walleye Wind, LLC (Applicant), along with Brian Murphy of Walleye Wind.

Suzanne L. Steinhauer, Environmental Review Manager, Department of Commerce Energy Environmental Review and Analysis (EERA), appeared on behalf of EERA.

Michael Kaluzniak, Senior Energy Facility Planner, Public Utilities Commission Energy Facility Permitting (Commission staff), appeared on behalf of the Commission staff.

Interested persons are invited and encouraged to participate in this informal process and need not intervene as a party. They should subscribe to one of the cases, using one of the MPUC Docket numbers, in eDockets and monitor filings and attend one of the public hearings where they will be able to make comments and ask questions of the Applicant and EERA. Interested persons should address whether the proposed wind farm meets criteria under Minn. Stat. ch. 216F and Minn. R. chs. 7849 and 7854.

Based upon the record and the discussion among the participants at the prehearing conference,

IT IS HEREBY ORDERED:

- 1. No later than **April 13, 2021**, Commission staff will publish notice of the availability of the Environmental Report and Draft Site Permit, and the Notice of Public Hearing in the EQB Monitor and by any other appropriate means.¹
- 2. Two public hearings will be held on the applications on **May 4, 2021**. Hearings will be held at **1:00 p.m.** and at **6:00 p.m.** In accordance with current protocols in place to limit the spread of COVID-19, the hearings will be held remotely via telephone and internet connection. Commission staff will provide instructions in the Hearing Notice on hearing access and participation. The Applicant is to provide a summary of the applications at the hearings, including the need for the facility and its location, as well as any other issues that are or may be controversial or of interest to the public. Questions from the public will be entertained by the Applicant, EERA, and Commission staff, as appropriate.
 - 3. The last day for written public comment will be **May 20, 2021**.
- 4. Commission staff will complete the compilation of public comments received no later than **May 25, 2021**.
- 5. No later than **June 2, 2021**, Applicant will serve and file proposed findings of fact and replies to public comments.
- 6. No later than **June 16, 2021**, EERA and other parties will serve and file comments on Applicant's proposed findings.
- 7. No later than **July 16, 2021**, the Administrative Law Judge will issue a report in accordance with directions from the Public Utilities Commission.
- 8. Parties may serve and file exceptions to the Judge's report no later than **August 2, 2021**.
