Dear Mr. Seuffert:

This letter is intended to clarify the resolution of clarifications requested by the Minnesota Commerce Department, Division of Energy Resources (Department) in initial comments filed on July 26, 2021 in Docket No. E015/M-21-349. In those comments, the Department requested that Minnesota Power (Company) clarify its reasoning behind the Company's statement that it will not request recovery of costs associated with its deferred accounting request in its upcoming rate case, and that Minnesota Power explain where and when it plans to recover the deferred costs addressed in the Petition filed May 21, 2021 in the instant docket.

On August 2, 2021, Minnesota Power filed reply comments stating that including costs associated with the deferred accounting request in the upcoming rate case would "split cost recovery between two rate cases" and would burden the upcoming rate case with another issue amidst many items and costs to evaluate. In addition, the Company stated that it intends to "recover these costs in a future rate case once the pilot program has concluded." 2

The Department appreciates the Company's clarification and has no further questions in this matter. Department staff are available to answer any questions the Commission may have.
