In the Matter of Possible Amendments to Rules Governing Certificates of Need and Site and Route Permits for Large Electric Power Plants and High-Voltage Transmission Lines, Minnesota Rules, Chapter 7849 and 7850; and to Rules Governing Notice Plan Filing Requirements for High-Voltage Transmission Lines, Minnesota Rules, part 7829.2550

Commissioner Lange moved that the Commission:

- 1. Revise the attached draft rules as follows:
 - a. 7849.0010, subp. 6. Associated facilities. Make no changes to this definition.
 - b. 7849.0010, subp. 14. Large h high voltage transmission line; LHVTL. Retain the following language: "associated facilities necessary for normal operation of the conductor, such as insulators, towers, substations, and terminals."
 - c. 7850.1000, subpart 3. Associated facilities. Make no changes to this definition.
 - d. 7850.1000, subp. 9. High voltage transmission line or HVTL. Retain the following language: "associated facilities necessary for normal operation of the conductor, such as insulators, towers, substations, and terminals."

- e. 7850.1650, subp. 2. **Notice content.** Require that under "A," the applicant's name <u>and</u> <u>contact information, including physical address, phone number, and email address</u> be filed.
- f. 7850.1680, subp. 1. **Comments.** Modify the draft language to require the Department to notify the Commission of any deficiencies in the draft application within 10 days after the draft application is filed.
- g. 7850.2110, subp. 1. **Notice.** Change the 20-day initial comment period to 21 days.
- 2. Authorize staff to take the necessary steps to continue the rulemaking process.
- 3. Delegate to the Executive Secretary the authority to execute documents necessary to proceed with rulemaking under the Administrative Procedure Act up to, but not including, rule adoption.
- 4. Delegate to Commissioner Tuma the authority to approve any necessary, non-substantive edits to the draft prior to publication in the *State Register*.

The motion passed 5–0.
