Comments of the Minnesota Department of Commerce Division of Energy Resources

Docket No. E015/M-18-713

I. BACKGROUND INFORMATION

On November 13, 2018, Minnesota Power (MP or the Company) submitted updated tariffs to comply with the Minnesota Public Utilities Commission's (Commission) August 13, 2018 *Order Establishing Updated Interconnection Process and Standard Interconnection Agreement* in Docket No. E999/CI-16-521. In addition, MP requested approval to increase the threshold for using the Uniform Statewide Contract from 20 kW to 40 kW.

II. DEPARTMENT ANALYSIS

In its August 13, 2018 *Order Establishing Updated Interconnection Process and Standard Interconnection Agreement*, the Commission adopted new procedures for interconnecting distributed generation systems (Minnesota Distributed Interconnection Process – MN DIP), and a standard interconnection agreement (Minnesota Distributed Interconnection Agreement – MN DIA). Minnesota Power has submitted revised tariffs for its Rider for Parallel Generation, Rider for Standby Service, Rider for Distributed Generation Service, and Electric Service Regulations. The revisions are limited to changing the threshold for signing the Uniform Statewide Contract to 40 kW, and referencing the Minnesota Distributed Energy Resource Interconnection Agreement. MP further incorporated by reference the MN DIP requirements into its tariffs.

While the Department does not think it necessary that a utility include the entirety of the MN DIP and MN DIA in its tariffs, language describing the general process, timelines and fees and the MN-DIA should be included in the tariff. Simply referencing the MN-DIP and MN-DIA without including any details is insufficient. For example, the MN-DIP sets out a Simplified Process, Fast Track Process and Study Process to be followed for interconnecting distributed generation facilities depending on the size and complexity involved. Each process has specific eligibility requirements and timeframes associated with it, and should be detailed in the appropriate MP tariff. In addition, the standard MN DIA should be included in the tariff.

The Department requests that MP submit a revised tariff including sufficient details of the MN DIP and the MN DIA to inform customers of the various processes, timelines, and fees, and incorporating the standard MN DIA.

The Department does not object to MP's request to set the threshold for signing the Uniform Statewide Contract rather than the MN DIA at 40 kW. Section 1.1.5.2 of the MN DIP states,

The Area EPS Operator may propose in its tariff an increase to the size threshold for the application of the Uniform Statewide Contract as a replacement for the MN DIA in its tariff.

The MN DIP permits use of the Uniform Statewide Contract rather than the MN DIA under the circumstances requested by MP. The Department recommends approval of MP's request.

III. DEPARTMENT RECOMMENDATION

The Department requests that Minnesota Power submit a revised tariff including details of the MN DIP and the MN DIA. The Department will offer additional recommendations after reviewing the tariff revisions.
